

Remote learning plan for 2020-21

In the event of your child needing to self-isolate, remote learning will be provided. The aims of this document are to:

1. Outline when remote learning will be provided
2. Outline what staff will provide
3. Provide details of how and when the learning will be provided
4. Share details of who to contact with any queries
5. Responsibilities of parents/carers

1. When will remote learning be provided?

- In the current January Lockdown window.
- If your child has to self-isolate on the advice of a clinician, 'Track and Trace' or Public Health England.
- If your child or anyone in your household has COVID symptoms and you have reported this to school.

2. What will staff provide?

Update – January 6th 2021

In Key Stage 1 and 2 all children have a login for Google Classroom where their teachers are providing lessons for the children to complete daily. There will be a minimum of 3 hours in key stage 1 and 4 hours in key stage 2. This will be a mix of live learning with lessons taught by the class teacher and offline tasks the children can complete outside of the live learning sessions. Children will receive feedback on their learning in line with what we do in school in the children's books.

In key stage 1 and 2 we will be following our planned curriculum and topics for the term with a focus on basic skills and English and maths. Teachers will provide a timetable for remote learning that will be posted to Class Dojo and will inform you of any changes to the timetable should there be any. There will be an English lesson; a maths lesson and an afternoon session that is live with the teacher everyday. These may last anything from 30 - 90 minutes depending on what work has been set.

Whilst isolating, if you experience any welfare issues (e.g. lack of food or lack of a device), please phone the school office and request a call from our Family Support Worker, Holly.

5. Responsibilities of parents/carers

- If your child is unwell and unable to complete work, please phone the school office and report your child absent as usual.
- If your child is well, please ensure they complete the work set
- Please read the rules of any 'Google Meet' sessions before participating
- Please ensure they and their children contact teachers within working hours (8.30-3.30) where possible, and do not expect an immediate reply. Staff are not expected to reply to emails or platform posts outside of their working hours.
